## 1. About the role

Jubilee Debt Campaign is recruiting a Senior Policy and Campaigns Officer to take forward our work on global South debt. This is a new, key role in the organisation and crucial to the success of our campaigns. You will be joining at a time when international debt is gaining in prominence as an issue, and it is crucial we campaign for a just response in the midst of the Covid-19 crisis and the climate emergency.

You will be working on our campaign on the global South debt crisis, as part of the global South project team alongside the Head of Policy, Head of Campaigns, Digital Campaigner and Director.

## You will:

- Monitor policy developments, advocate for just and transformative solutions, and research and publicise compelling data and analysis that illuminates our campaigns to decision-makers, influencers, activists, and the media
- Liaise with allies around the world to develop joint campaign strategies based around acting in solidarity with people in countries affected by unjust debt
- Support our work in Parliament on international debt, building relationships with MPs and advisors, monitoring parliamentary developments, and identifying actions MPs can take to support our campaigns
- Work with Jubilee Debt Campaign activists, helping them to understand and take action on the issues, including lobbying their MPs

We are looking for someone with strong research and policy analysis skills, a strong campaigning mindset, experience of advocacy and statistical analysis, and a passion for social justice. We are not expecting you to already be an expert in all aspects of the role, but are looking for someone with the potential to develop quickly under the guidance of our Head of Policy.

We strongly value diversity and welcome applications from applicants from all backgrounds. We particularly encourage applications from people with a Black, Asian or minority ethnic (BAME) background.

The is a permanent role being offered on either a full-time basis or four days per week (35 or 28 hours). We offer pension contributions of up to 7.5% of your salary plus 1% of the average organisational salary, an annual leave entitlement of 30 days per year per annum plus bank holidays, and flexi-time working arrangements outside the core hours of 10am-4pm.

The role will be working from home until Jubilee Debt Campaign decides it is safe for staff to return to working in the office. The office is in London and the salary includes a London weighting allowance.

#### 2. About us

Jubilee Debt Campaign is a UK charity working to end poverty, inequality and exploitation caused by unjust debt. We do this through research, education, and campaigning, based around the principles of solidarity and partnership. We seek to strengthen the global movement for economic justice through everything we do.

Our vision is of a world that is fair, democratic and sustainable, where everyone has their basic needs met, their human rights respected, and the opportunity to flourish, live a dignified life, and contribute to their community and to society as a whole. This is a world where finance and the banks serve the public interest, and where no-one is exploited, oppressed, or driven into poverty by debt.

We have a small, highly-skilled team with an agile, creative, and flexible approach, a network of local activists across the UK, a growing community of online activists, and a strong network of allies in the UK and around the world. All of this adds up to a big impact, relative to our size. Key victories in recent years include:

- \$130 billion of debt cancellation for developing countries as part of the Jubilee 2000 campaign
- An Act of Parliament to protect 40 poor countries from being sued by vulture funds in UK courts
- \$100 million of debt cancellation for Ebola-affected countries: Liberia, Sierra Leone and Guinea
- A cap on interest and charges for rip-off 'rent-to-own' products
- Up to \$12 billion of developing country debt suspended in response to Covid-19

In 2015 we revised our charitable purpose to enable us to bring our expertise and experience of working on debt crises in developing countries to bear on the debt problems and opportunities facing the UK economy. We've just finalised a new strategy with ambitious goals to guide the next 3-5 years of our work.

# 3. Role Responsibilities

The main responsibilities for the Senior Policy and Campaigns Officer are:

### Policy and research

- Keep up-to-date with and respond to new issues and developments in international debt, including research and analysis, official processes, and policy discussions
- Conduct research and data and policy analysis to advance campaigning and advocacy goals
- Research stories for media and social media to build campaign momentum
- Write reports and briefings
- Manage relationships with allies in the global South, Europe and the US
- Produce a regular update on debt for affiliates and other interested parties
- Act as a point of contact for affiliates and other interested parties on debt questions

## **Advocacy**

- Build and maintain relationships with a range of political stakeholders on issues of international debt policy, including Ministers, Parliamentarians, and officials
- Help to build and maintain a group of Parliamentary champions on international debt
- Monitor parliamentary engagement on issues related to international debt
- Identify and submit to appropriate Government and Parliamentary consultations
- Support advocacy activities towards the World Bank and IMF, including liaising with officials and producing written submissions

## **Campaigns & Movement-building**

- Public speaking to a range of audiences on Jubilee Debt Campaign's campaigns
- Train and support activists to take part in campaigns, including to lobby MPs and decision-makers
- Help draft or source accessible and engaging campaign content, including for the website and campaign newsletter
- Support civil society coordination, including organising and facilitating meetings and conference calls with allies from the UK and around the world

### Media

- Assist with monitoring media coverage of Jubilee Debt Campaign and news related to debt
- Draft and distribute press releases and help brief journalists

## Organisational

- Input into the development of organisational and campaign strategy
- Support with fundraising, including helping draft reports to funders
- Manage project budgets where appropriate
- Participate in team discussions on strategy and day-to-day operations and help with facilitation
- Support the team with shared responsibilities around administration

# 4. Person Specification

#### **ESSENTIAL**

- Proven ability to analyse and create statistics, including for use in campaigning or with the media
- Proven ability to plan and deliver research which contributes to campaign or advocacy goals
- Proven ability to understand and clearly communicate issues of poverty, inequality, or economics to a wide variety of audiences
- Sharp policy analysis skills, and experience of developing policy positions on economic or social issues
- Experience of successfully lobbying decision-makers such as MPs
- Experience of working constructively in coalitions
- Excellent writing skills particularly writing for politicians, activists, and the media
- Strong networking, relationship-building and communication skills
- Ability to organise and manage a busy workload
- Experience of campaigning to achieve policy change objectives (in either a paid or voluntary capacity)
- Ability to work to deadlines and take responsibility for delivering projects without day-to-day supervision
- Effective project management skills, including putting systems in place, planning, monitoring and evaluation
- A positive, can-do attitude, willingness to 'pitch in', and ability to work collaboratively as part of a team
- Commitment to social justice and to tackling all forms of oppression, bigotry, and exclusion
- Support and enthusiasm for Jubilee Debt Campaign's vision and mission

### **DESIRABLE**

- Experience of public speaking
- Fluent in French, Spanish, Portuguese or Arabic

Applicants must have the right to work in the UK; unfortunately Jubilee Debt Campaign cannot sponsor visas for people who do not already have this right.

## 6. Further guidance on your application

These following notes are intended to help you complete the application form. This form is of vital importance as it provides the only information on which we can base our decision as to whether your skills and experience match the needs of the job and therefore whether to invite you to interview.

#### A. General

• Remember to complete all parts of the application form. If you think some parts do not apply to you, write 'not applicable' in the spaces provided for your answer.

#### **B.** References

- Remember to check with your referees that they are happy for us to contact them before you nominate them. We will not contact them without informing you.
- You are asked to supply details of referees that cover the last five years of your employment. One should be your current line manager, or your most recent line manager if you are not currently in employment.
- If you are unemployed, your last employer should be named and if you have any voluntary or unpaid experience, e.g. as a member of a committee, you could include the chair of the committee among your referees.

### C. Employment History

- Please give details to the nearest month and year of previous jobs held, and account for any gaps in your employment record.
- Some people will have developed many relevant skills through voluntary unpaid work. These details should be included on the form, particularly where the experience has helped you to develop skills and abilities that we have asked for.

### D. Education or Training

• In this section please include information about any relevant courses that you have attended, as well as your educational history from A-level (or equivalent) onwards.

### E. Supporting Statement

- This section gives you the opportunity to demonstrate why you are suitable for the post. Before completing it, please refer to the Role Responsibilities and Person Specification earlier in this pack.
- In this section of the form it is essential that you set out how your skills and experience meet each of the points in the Person Specification. Make sure that you give specific examples. This means telling us what you personally did in your role rather than what the team did. It also means giving us concrete examples of where you demonstrated a particular skill, rather than simply saying that you have it.
- We will assess how you meet every criteria in the Person Specification, so it is important that you try to address each specific skill or experience that is listed.

#### F. Criminal Convictions

• The fact that you have a criminal record does not automatically prevent you from being considered for a job. We will take into account the nature of the offence, when it happened and its relevance to the job. If you are shortlisted, this will be discussed with you at the interview.
